Emerado City Council Regular Council Meeting Monday, October 6, 2025. The city council met on September 8, 2025 @ 7pm, 201 Main Street. Future Council Meeting: November 3, 2025. Mayor Lanes presided and called the meeting to order at 7:00pm. Roll Call: T Wynn, J Linneman. Let record show all members present. Mayor Lanes explained we do not have a quorum to make any motions or votes. Mayor Lanes asked council if there was anything they would like to discuss. J Linneman asked about Dan's Evacuating bill, Auditor Klava explained it was for water leaks that he helped G Schmitz with. Police Report: Chief Lund stated he had 33 service calls, 8 case reports and 5 citations. He also explained he went and put sticker on the door of 104 E Hancock. That he went inside and it is bad, and not livable, and not up to code. He explained J Wilson is residing elsewhere until November. His wife and her mom owned it, but her mom passed away for her and her dad owns it now. The dad wants it demolished, and J Wilson is no longer allowed to live there. Chief Lund explained he had to give J Wilson time to get his stuff out next month. Chief Lund will talk to the owners next month and see what the plan is. Mayor Lanes stated that there are some youngsters in town that are authors. They have written 3 books and published 2 so far. There was a story about them on the front page of the Herald. Mayor Lanes stated he wanted to congratulate them. Mayor Lanes also state there was a Halloween party at the Community Center on Halloween from 6-7pm following the Trunk or Treat on Main St. Also, turkey bingo will be held on November 21st, not sure on the time yet. Public Comments: E Bader explained there were about 40 people at the spaghetti feed, so it went well so that was a boast for the Endowment Fund. Christmas tree lighting will be coming up on the 1st Saturday of December. The principal of Emerado School asked about flooding the ice rink. Mayor Lanes explained that it will be done by the person who put up the rink as he does every year. Mayor Lanes also stated the Rado Run will be January 3, 2026. M Belgarde asked when her yard would be leveled as it is still ripped up from the water leak repair. Mayor Lanes stated he would take care of it. L Berger asked how long before council member could be appointed? Mayor Lanes explained he would check with City Attorney on how to proceed and double check how long we have to leave open until we can appoint someone or to get on the ballot. Mayor Lanes explained if they knew anyone interested to let him know. L Berger also stated he had purchased the lot from D Henneman and is moving in a house to the lot in about 2 weeks, asked what permits he needs. L Berger also stated they got the ok from the health department so they will be tearing it down and hauling it to GF. M/S/C (TW) Adjourn.
