Mayor Lanes explained the property at 106 Brisbane (Glaum) had been cleaned up. Acks was served paperwork for the 4 trailers that were to be removed, but nothing has been done with that, not sure if it has to do with the trailer court being sold and new owners taking over as of January 2025. Property at 400 E Emery Ave (R Gruber) has been partially demolished. The auditor explained she talked to the people who were working on it, and they had stated they are done and are not doing anymore. The city will hire for the demolition of the trailer and removing it and assessing the property owner for the cost. Dietzler Duplex Curb stops: Auditor and G Schmitz explained the curb stops have been repaired to the city's satisfaction. CPA: Auditor explained she has met with an individual to help with the bank reconciliations, but she is not a licensed CPA, but she is an accountant for another local business in Emerado and could help with the reconciliations. The mayor and Attorney Warcup would like the auditor to check to see if she would need to be bonded or not. The auditor will contact ND Insurance Reserve. Money Market/CD for the Prairie Dog Funds: The Prairie Dog monies (\$58,352.65) have been moved into a money market at Alerus Financial. Emerado Raffle Permit: Mayor Lanes explained the Emerado Fire Dept has requested a permit for the raffle of a snowmobile during their Rado Run in January.
