Police Report: Chief Lund stated he had 27 calls for service, 6 citations, 3 case reports. Chief Lund reports there are 8 registered sex offenders within the city. He also is still working on the junk vehicles around town. Two of the residents have been cited to court on 3/11/2025 for the junk at 200 King St. He will also be sending out final notices to a few residents for the junk vehicles. Municipal Permits: Mayor explained he had sent an email to the council to review before the meeting to see if they are interested in changing anything regarding the permits as it's been a long time since any change has been made. The council agreed changes need to be made on the pricing and that the draft looked good. So, the draft will be sent to the City Attorney for him to update the ordinance and the first reading could be done at next meeting. It was tabled to next meeting. Rezoning Property at Folson's 2nd Addition, Lot 1, Block 1(Doc Holidays). Mayor explained Bergers were interested in having the property rezoned and presented a petition at the last meeting. Bergers stated they would like to have the bottom of the building commercial and the top residential. Also putting 6 townhomes on the property behind (Brisbane Ave). They stated they would be rentals but could possibly be for sell also, not sure yet. And that there was alot of work yet to do with tearing the building which they are having hard time finding contractor to do it and also having all the land surveyed. Attorney Warcup explained the properties would need to be rezoned and there was a few different zoning options and that there would need to be a public hearing on it. It was tabled to next meeting. Spring Cleanup Dates: Dates for Spring Cleanup will be May 12-19. Auditor will contact WM and set up to have 2 dumpsters for junk and 1 for brush/trees. Past Due Water Accounts: Mayor Lanes explained we had residents from the NorthernView MHP here today due to the water being shut off in the park due to nonpayment by the owner. Mayor Lanes opened it up to the public. Residents voiced their opinion on the shut-off to the park, stating didn't think it was fair when they paid their bill to the owner and then the water got shut off. Mayor Lanes explained there was only one master meter for the park. Residents voiced their opinion on getting separate meters. Mayor Lanes explained the only thing they could do was look up ND Tenant Laws and go after the owner of the park, as the city was following the city ordinance on the water shut off. No other comments from the public.
