If not cleaned up another citation can be issued or the city may clean up the property. Chief Lund he attend the Chief of Police training in Grand Forks.. J Linneman asked if he had looked into grants for the police vehicle, Chief Lund has not. He will look into Lions Club, Enbridge, etc. Rezoning Property at Folson's 2nd Addition, Lot 1, Block D (Doc Holidays)-Mayor explained back in February 2025 Berger brothers approached council about rezoning the property. Attorney Warcup stated the council had already changed the ordinance so no zoning changes would need to be done. Just a Motion to postpone it indefinitely until Berger brothers are ready. (TW/TH) Motion to postpone rezoning of the property until Bergers are present. Road Repairs: Mayor explained the intersection of Emery and County Rd 3 is going to be repaved and the county approached city about sharing the cost as city needs repaving done on Emery Ave. Mayor Lanes explained it would be saving the city money by partnering with the County. Mayor Lanes will get the price from Nick at the County. Mayor Lanes talked about the section in front of the Fire Dept and has put a news release on the city app. Fire Dept hired contractor to replace the apron however with conversations with an engineer the road in front of fire station is washing out underneath and has been deemed an emergency. Discussion was made with the council to work on cities portion which is 750 sq feet into roadway, so it can all be completed at one time. Mayor Lanes and council complimented Glenn on the patchwork he has done on the roads around town. Mayor Lanes did ask that he go and check out D Ave as it needs some patchwork. Audit Report—Auditor explained that the State Auditor's Office was not going to complete 2014-2019 due to fraudulent activity and mark them as completed. They have completed a basic review of 2020-2022. So, they will begin 2023 and 2024 so the audits should be done soon. Mayor Lanes explained that State Auditor's Office and the City Auditor J Klava have put in a lot of work to get these completed and thanked her. Budget Meeting scheduled for July 8, 2025 at 6pm.

Mayor Lanes opened it up to the public. G Schmitz stated he sprayed all the trees and got them cut down at the lagoon, but the mower needs to have a bat wing mower. Mayor Lanes stated he would give him the mowers number so they can meet out at the lagoon so he can show him what he needs to do. Deputy M Dudgeon stated he got the request for extra patrol due and will put in the request, as the fire trucks/equipment are unsecured where they are

parked. R Gruber stated the owner of the park will be in town 7/19/25 and they are having a clean-up potluck and everyone is invited. She also stated she would like the building inspector to come and look at 2 trailers she would like deemed dangerous. Chief Lund will meet with her. Stated all trailers are sold rent-to-own except 3. F Renfrow stated there is a lot of water standing in the ditches. G Schmitz will look at them.
